

Food - Introduce "Meat-free Mondays" into your weekly schedule



Finance - Move your banking and super to companies committed to sustainable investment





Water - Make sure you are using a water-saving shower head & check the temperature of your water system

I introduced the Climate Change Bill into Parliament in November and it is now before a Parliamentary inquiry with the *Standing Committee on the Environment and Energy*. The Committee asked for feedback from the public and organisations and it received over 6600 submissions, which is a fantastic result.

Submissions were made by the UK Climate Change Committee, the Business Council of Australia and many Warringah residents. There were a number of presentations during the two public hearings on the 29th January and 1st February.

### NDIS

My team and I regularly assist community members who are participating in the National Disability Insurance Scheme (NDIS).

We have heard concerns in the community about the proposed Independent Assessment Scheme which will overhaul the way people are assessed for their plans.

We have also heard firsthand accounts of the difficulties some people face obtaining adequate plans and the workload and stress that this often causes.

With these concerns in mind, I am hosting an online forum for participants with the National Disability Insurance Agency, their carers and providers, with a senior officer of the NDIA.


### **WORKING FAMILIES**

COVID-19 exposed weaknesses in our ability to support working families through the current childcare system which was reflected in the multiple changes in funding during the pandemic. My electorate office received many calls from distressed parents, childcare centre operators and staff of childcare centres.

I believe we can do much better in supporting working families and add to our economic growth in the process. This view is supported by new research published by the Parenthood Group and Equity Economics.

In support of this research, I will be tabling a motion in Parliament on 15 February, calling on the Government to:

- 1. Increase health and wellbeing support for parents and children by amending parental leave legislation to provide for a year of paid parental leave that can be shared by both parents;
- 2. Lower the cost of early childhood education for all families; and
- 3. Improve access to paid carers' leave for parents of sick children.



I have been nominated to be on the 10 Terminal Reference Group that the Harbour Trust has formed to assist the 10 Terminal and Parklands Renewal Project. I would welcome your feedback on the future project direction of this important site at Middle Head in Mosman.

I have also joined the North Head Sanctuary Bushfire Recovery Group, which has been set up by the Harbour Trust to support and coordinate recovery efforts following the bushfire at North Head on 17 October 2020. I know the fire concerned many local residents who care deeply for North Head and its many animals and plants.

As well as sharing relevant local knowledge and expertise, the Group will consider best practice approaches to land and bushfire management at North Head. ### INTEGRITY AND TRUTH IN POLITICAL ADVERTISING

Last year, a key area of legislation that the crossbench took on was the push for greater integrity in federal politics. This culminated in the presentation of the Australian Federal Integrity Commission Bill by Independent MP Helen Haines in late November, a Bill that I seconded.

Building on that theme, this year, I will table a new Bill on truth in political advertising. Australia Institute polling shows that 9 of 10 Australians want truth in political advertising legislation. In 2020, the ACT became the second State/Territory to adopt truth in political advertising legislation, following in the footsteps of South Australia.



There are many grant opportunities that can help our community here in Warringah. My office has assisted schools, community groups, sporting clubs, veterans representatives, businesses and individuals in our electorate to share in the several hundred grants that we have been awarded.
